PART I. General Expectations

Hamlet Elementary agrees to implement the following statutory requirements:

PART II. Description of how Hamlet Elementary will implement the required components of the campus Title I Parent Engagement Plan.

1. Hamlet Elementary will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Hamlet parents will receive an invitation by phone, Tuesday folder and school messenger to attend its campus PEP meeting. Meetings will be held at various times at the school campus.

2. Hamlet Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - The Campus Improvement Plan committee consists of school administrators, classroom and non-classroom professionals selected by their peers, a parent representative, a community representative and a business representative. The committee will review the 2017-2018 Campus Improvement Plan and make changes as needed to the plan.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - The Campus Improvement Plan will be presented to the Hamlet staff members on August 7, 2017 during teacher staff development.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Hamlet Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Hamlet Elementary annual meeting to inform parents of the school's participation in Title I, Part A program will be held during the Back To School Night.
- Additional meetings will be held as per parent request.

4. Hamlet Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Parents will be provided this information at the Title 1 Back to School Night in September 2017-2018 school year.

5. Hamlet Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Monthly meetings
- Parent Teacher Conferences
- Tuesday Folder communication

6. Hamlet Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Posting all results on AISD website.

7. Hamlet Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- How to establish and maintain a parent- teacher relationship.
- How to use Skyward to monitor your child's academic progress.
- STAAR TEST

8. Hamlet Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- STAAR Night
- Literacy Night
- Discovery Center Night
- Parent Engagement Programs – Strengthening Families Program
- Skyward Parent Training
- Material/Information sent home in Tuesday folders offering various parent training opportunities

9. Hamlet Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Training during teacher professional development
- Information from parent surveys

10. Hamlet Elementary will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Disseminate information to parents informing them of the programs that are available to them.

PART III. Discretionary Components of the Hamlet Elementary Title I Parent Engagement Plan
